B. PETS

In the case of matters relating to pets, an Owner or Occupant shall not keep or allow any pet of any kind at any time to reside in their Unit or on the Common Property without the prior specific written approval of the Board, which approval the Board may arbitrarily withhold and may, if given, be withdrawn anytime on fourteen (14) days' notice to that effect in which event the applicable pet shall be removed forthwith from the Unit and the Common Property. Additionally:

- (a) no spider, snake, insect, reptile, livestock or fowl is allowed in a Unit or on the Common Property;
- (b) all approved dogs and cats must be hand leashed on Common Property outside Privacy Areas and kept under control at all times. No pet shall be tied or left unattended on a Privacy Area;
- no aquarium holding water in excess of twenty (20) U.S. gallons shall be permitted;
- (d) birds shall at all times be caged;
